The BMO Harris Office Tower, regional headquarters for one of the ten largest banks in North America, was designed to deliver the next generation of workplace to Milwaukee's financial district and is being named one of the city's newest landmark projects.

Positioned in the heart of the Central Business District, BMO Tower's contemporary design is a striking addition to Milwaukee's urban core and offers a prominent yet accessible location in a highly walkable area, surrounded by the city's most popular attractions, situated right near Milwaukee's iconic City Hall. With low vacancy rates for Class A office spaces in Milwaukee, local government officials recognize the need for the BMO Harris Office Tower project.

This fully capitalized, glass tower is currently under construction and perfectly suited for EB-5, with an anticipated economic impact of over 1,400 construction jobs. The 25-story, 35,379 square meter vertical business campus provides 653 parking garage spaces and opens in December 2019.



#### **ASQ** Center

A rapidly deteriorating, historic department store building built in the 1880s needed new life. Where other developers saw great risk, Irgens and project partner, Williams Development Corporation, saw great potential. A complete building transformation ensued and the "white elephant of downtown Milwaukee" as it was known, was transformed into a highly successful, 37,161 square meter, mixed use property that became the catalyst for the downtown area resurgence.



#### 833 East Michigan

The 18-floor, 33,260 square meter multi-tenant office building includes LEED-certified and technology-driven design for optimal IT access and energy efficiency, an on-site fitness center, multi-media conference center, restaurant, 459 parking stalls, and a skywalk connectivity to the US Bank Center Galleria. 833 East features a four-story lobby with floor-to-ceiling windows offering panoramic views of Lake Michigan and the downtown Milwaukee skyline.



#### **GE** Healthcare

After a competitive regional search for a new site to locate three GE Healthcare divisions, the company selected Irgens' proposal for a new, 47,027 square meter building to be developed and owned by Irgens on a 25 acre land site. The building was completed and designed to be a premier showplace for the client's innovative products and services. Several years later, Irgens sold the property to a high-quality institutional investor. The sole tenant, GE Healthcare, continues to hold a long term lease.
